2. Roll Nos denoted with asterisk (**) have been declared medically unfit during the Initial Medical Examination held at Military Hospital, Gaya. Admission of these candidates will be subject to their medical fitness. 3. The candidates declared medically unfit have a chance to appeal for an Appeal Medical Examination. Therefore, those who wish to make an appeal against the Initial Medical Board Findings must apply in writing to the Principal, Sainik School Nalanda latest by 25 Mar 2020 along with ₹ 100/- and medical opinion of the competent medical authority to counter the findings of the Initial Medical Board. After examining the appeal and medical opinion produced by the parents/guardians, the Principal, Sainik School Nalanda may arrange an Appeal Medical Exam for the candidates. The candidates permitted to appear for Appeal Medical Exam will be required to appear before the Appeal Medical Board at the designated hospital on the date and time as specified by the School at their own expenses and risk. 4. The details of the medical category may be collected from the School on any working day between 0830 h - 1330 h on production of Call Letter issued by the School for Medical Examination. Call letters/Joining Instructions are being dispatched to the medically fit candidates in the Main List by Registered Post. 5. The School is not responsible for any printing error. The candidature of the candidates is subject to verification with the official list held with the School. 6. The candidature of the candidates will be cancelled, in case of failure to report to the School on the date stipulated for the admission or failure to submit/produce the requisite documents. Candidature can also be cancelled even after admission, if, it is, found at any stage that the information/documents submitted by parents/candidate are false.

7. Those candidates who are referred for Eye are required to report to the Military Hospital, Gaya on 21 Mar 2020 at 0700 h for review medical examination by Eye specialist which has been denoted with asterisk (*) above and admission for these candidates will be subject to medical fitness by Eye/Skin/Dental specialist.
