2018-19: LETTER TO THE CANDIDATES FOUND MEDICALLY UNFIT BY THE MEDICAL
EXAMINATION BOARD HELD AT MILITARY HOSPITAL, DANAPUR FROM 12 MAR 18
TO 16 MAR 18

Dear Sir/Madam,

- Reference is made to the Medical Examination held for the short listed candidates of All India Sainik Schools Entrance Examination 2018 at Military Hospital, Danapur from 12 Mar 18 to 16 Mar 18.
- Your son/ward Roll No **ROLL NO** Master **CANDIDATE'S NAME** has been declared 'MEDICALLY UNFIT' for admission to Sainik School Nalanda by the Medical Examination Board for the following reason(s):-

REASON

- As per the final order of merit, your above named son/ward has been placed in the **STATUS** under **CATEGORY** category. Your son's/ward's admission in Sainik School Nalanda or in any other Sainik School is subject to final order of merit, medical fitness and availability of vacancies.
- The candidates declared medically unfit have a chance to appeal for an Appeal Medical Examination. **Therefore, in case you wish to make a request for an Appeal Medical Examination, you must apply in writing to the Principal, Sainik School Nalanda latest by 02 Apr 18.**
- Option 1.** If you agree with the findings of the Medical Examination Board and interested in getting the medical abnormality found in your son/ward cleared by way of medical treatment (**only if, it is, curable**), the Principal, Sainik School Nalanda may grant you time (not more than 42 days for treatment as well as recovery from the date of issue of this letter) for the said medical treatment for which you have to submit a written application to the Principal, Sainik School Nalanda **latest by 02 Apr 18** duly supported by a certificate issued by a Registered Medical Practitioner (Specialist) clearly stating the duration required for medical treatment/recovery.
- Option 2.** In case, you wish to make any representation against the findings of the Medical Examination Board, you should **apply to the Principal, Sainik School Nalanda in writing and report to this School along with your son/ward on or before 02 Apr 18.** Your contention against the findings of the Medical Examination Board should invariably be supported by a medical fitness certificate issued by a Registered Medical Practitioner (Specialist), preferably by the Civil Surgeon of your district.

7. However, **the Principal, Sainik School Nalanda after examining the evidence produced before him shall reserve the right to entertain or reject any such request on merit of the case.** On consideration of appeal for Appeal Medical Examination by the School, you along with your son/ward will be required to appear before the Appeal Medical Examination Board at the designated place and time as given by the School at your own expenses and risk. The School shall charge R 200/- (R 100/- for SC/ST) for holding Appeal Medical Examination.

8. It may be noted that mere qualifying in the medical examination does not guarantee admission of your son/ward in this School or in any other Sainik School. Admission will be made strictly as per the final order of merit list and availability of vacancies.

9. You may ignore this letter, incase you are not interested in Appeal Medical Board for your son/ward. Also, note that no applications will be entertained by this School after **02 Apr 18** for Appeal Medical Board.
